The language of the Peshitta, Syriac, is a dialect of Aramaic similar to the dialects used by Jesus and the Jewish exilic communities. While the New Testament of the Peshitta can help uncover the original ideas behind the Greek text, the Old Testament of the Peshitta is full of variants that are not preserved in either Hebrew or Greek versions of the Bible but are connected to the ancient Jewish exegetical tradition.

ILLUMINATING VARIANT READINGS

Luke 6:35, Revised Standard Version:

But love your enemies, and do good, and lend, **expecting nothing in return.**

Most witnesses have, “love your enemies, do good to them, and lend expecting nothing in return” (μηδὲν ἀπελπίζοντες). However, a very few (e.g. W Ξ sys) have a text that supplies a personal object for the verb (μηδένα), thereby requiring a different meaning for the verb, “to disappoint,” or more literally, “to cut off one’s hope.” The Peshitta and the Sinaitic manuscript of the Old Syriac clearly share this distinctive text.

Daniel 11:16, Revised Standard Version:

But he who comes against him shall take the actions he pleases, and no one shall withstand him. He shall take a position in **the beautiful land**, and all of it shall be in his power.

In this engaging first memoir, George A. Kiraz tells the story of a young Palestinian boy growing up in Bethlehem, fascinated with understanding his Syriac roots even as he drew steadily nearer to the day when he would inevitably be transplanted to the United States.

Tracing his ancestors' migration from Upper Mesopotamia—present-day Turkey—to Palestine in the aftermath of the horrific Sayfo genocide of 1915 (known more popularly as the Armenian genocide), he provides a personal history of the Syriac presence in Jerusalem and Bethlehem. He then describes the realities of that presence through memories from his own boyhood, offering an intimate look at myriad aspects of Syriac life in Palestine in the 1970s and '80s: church community and religious identity, brushes with ancient history and artifacts, conflicts with the Israeli occupation, fraught custodianship of Christian holy places in Bethlehem and Jerusalem. Readers will meet many of the community members who influenced and encouraged George in his nascent academic interests, and they will even learn about his father's role in the legendary discovery of the Dead Sea Scrolls.

George is known for his contributions to Syriac studies and to the preservation of the Syriac language and heritage. These tasks, though, are not just the sum of his professional CV; they are the story of his life, his ancestry, his family's survival. This memoir chronicles his lifelong investment in the Syriac world and the childhood experiences that would later shape so much of his later academic life.

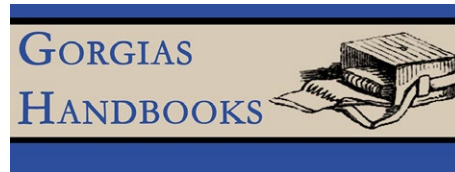

Colophons across Space and Time

Edited by Sabine Schmidtke & George Anton Kiraz

The colophon, the ultimate or “crowing touch” paragraphs of a manuscript or a book, provides readers with a the historical context in which the scribe produced the manuscript (or the publisher, a book). At its most fundamental level, the colophon gives us the “metadata” of the manuscript: who was the scribe? When and where was the manuscript produced? For whom was it produced and who paid for it? But colophons are far more rich. They are literary works in their own right, having a style and rhetoric independent of the main literary text of the manuscript. Some are assertive, providing contextual data about the scribe/publisher and manuscript/book; others are expressive, demonstrating the scribe’s feelings and wishes. Some are directive, asking the reader for an action; others declarative, providing all sorts of statements about the scribe/publisher or even the reader. The latter sometimes

provide historical facts otherwise lost to histories: wars, earthquakes, religious events, legal agreements, etc. This edited volume brings together scholars from various disciplines to study colophons in various languages and traditions across space and time.

Traces of Sufism in British Romanticism

This work argues that there are traces of Sufism to be found in British Romanticism. It does not set out to prove that the six great British Romantic writers, William Black, William Wordsworth, Samuel Coleridge, Lord Byron, Bessie Shelley, and John Keats were Sufi poets but to argue that they were influenced by Sufism because it suited their earnest purposes and goals, and because in some of their letters and works they made several references to Sufi poets and their poetry. With the exception of Bernard Blackstone and a few others, most scholars of Romanticism have overlooked the impact of Sufism on Romanticism in favour of Christian and neo-Platonic Mysticism. This work fills in this gap by showing the magnitude of the influence of Sufism on the Romantics without negating the influence of other -isms. What elements of Sufism attracted the attention of the Romantics? And why were the Romantics attracted more to Sufism and Sufi poets than to Christian Mysticism and Mystic poets? The introduction defines terms such as “Mysticism” and “Sufism” and discusses the basic differences between both in relation to Romanticism. Other chapters discuss traces of Sufism in Romantic poetry with emphasis laid on imagination as a medium for the perceptions of Self and Other. The work traces the Sufi Paths of Love, Light or Illumination, and Knowledge in Romantic poetry. It argues that the gnostic, inward, and visionary journeys of the poets of both literary movements—in search of the abodes of Beauty, Truth, and Knowledge—ascertain their kinship.

New Perspectives on Ancient Nubia

Knowledge of the societies of ancient Nubia is regrettably narrow. Egyptologists tend to interpret Nubian political and social achievements as derivative of Egypt as a result of the prejudices of ancient royal propaganda as well as modern views of “Egyptian exceptionalism.” University departments, academic and public libraries, and the wider discourse about the ancient world, render Nubia all but invisible. Located at the nexus of the Nile Valley and savannah corridors, ancient Nubian peoples traded east African goods to Egypt, the eastern Mediterranean, and the Near East. The powerful Kushite empire attained political hegemony over Egypt in its 25th Dynasty (ca. 760–656 BCE), which saw the Kushite pharaohs engaging in international displays of power in the Levant, bringing them into direct conflict with the Assyrian empire. Commentary on these clashes is recorded in the Hebrew Bible, while the Christian New Testament speaks of the conversion of a treasurer of the “Candace of the Ethiopians”. This volume presents current research that centers Nubian history and archaeology and imparts this information from postcolonial and anti-racist perspectives. It seeks to bring research on Nubia to a wider scholarly audience, broadening Nubiology’s impact on Egyptological, classical, and biblical scholarship, while challenging scholarly biases and disseminating knowledge, expanding the understanding of African achievements and influences on the ancient world.

The Passover Haggadah, the quintessential Jewish book, began taking shape in the period of the Mishnah and the Talmud (ca. 100-600 CE). Even by 600, it did not look like it does today. Major portions were wanting, e.g., the story of eminent sages at a seder in Bene Beraq; the typology of the four sons; the midrashic expansion of the story of the exodus; the song *Dayyenu*. Those compositions (mostly) or borrowings were incorporated into the Haggadah between ca. 600-900 (the Geonic period). Such selections completed the Haggadah, producing the book used at Passover Seders to the present day. This study shows how the section of the Passover Haggadah known as *maggid* ("recounting") achieved its comprehensive structure and contents between ca. 600 and 900 CE (the geonic period).

Moreover, as Ahmet Ersoy (2015) has argued in his monograph on this book, architecture is a prism through which the authors offer a larger analysis of modernity in the Ottoman Empire; an analysis where built heritage serves "as an index for various stages in the transformation of the Ottoman state and civilization."

The reign of King Khusrō I (531–579 CE) was a key chapter in the history of the Persian Empire, but it was also an important period for the development of the Church of the East. The *Martyrdom of Mar Grigor Piran-Gušnasp* and the *Martyrdom of Mar Yazd-panah* offer a panoramic perspective onto the social, religious, and political life of Christians in the Sasanian Empire at this time. According to these contemporary accounts, the death of Grigor, the general of the Sasanian king's armies and a convert from Zoroastrianism to Christianity, triggered the conversion of other Zoroastrian notables, including the courtier 'Awira and Yazd-panāh, a judge who also died as a martyr three years after Grigor. This volume provides a critical text and commentary, as well as the first translation into English, of these two East Syriac texts, which have received little scholarly attention, although they are among the few Syriac martyr accounts from this period. These texts demonstrate how Persian Christians, despite sporadic persecution, were able to maintain a distinct identity while simultaneously acculturating to the norms of Iranian society, even taking on significant offices within the Sasanian administration.

Special attention is also devoted to relations between theory and practice, concerning ownership of lands, the land tax, redistribution and the common good, conditions for agriculture, and peasants' rights.

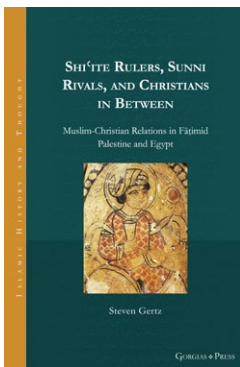

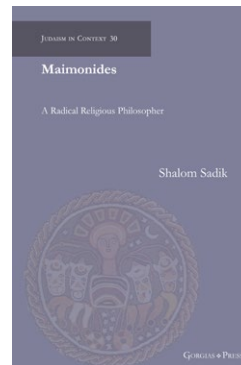

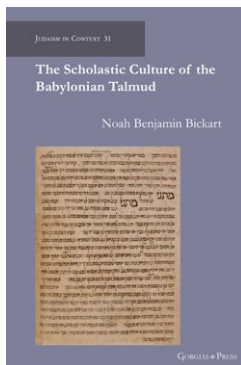

Was Maimonides a radical philosopher who subtly argued for a naturalist world and who saw the obligation to keep the Torah's commandments as a social and moral obligation – or was he a conservative Jewish believer who only tried to formulate philosophical arguments in favour of a revealed religion? This question has been central to the interpretation of Maimonides from the 12th century until modern times. In the four chapters of this book, Shalom Sadik argues for a radical philosophical interpretation of Maimonides. Based on this distinction, one can perceive the different aims of Maimonides in the *Guide* and thereby develop a modern method of interpretation of the book – a method which Sadik proposes

should be adopted by academic scholars. In the remaining three chapters, Sadik analyzes the opinion of Maimonides on the topics of the nature of free will and the psychological process of choice; examines the question of the epistemological importance of commonly accepted opinions; and deals with the relationship between the Biblical commandments and the question of natural law.

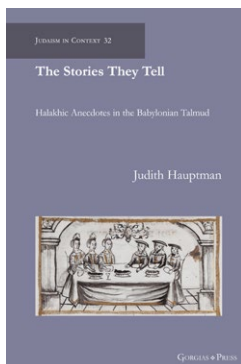

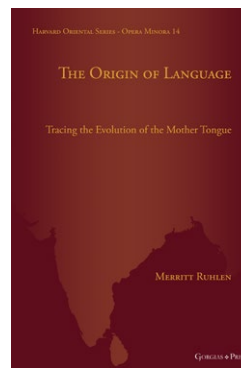

Therefore, *Opera Minora* includes the publication of seminal conferences, archeological reports, important dissertations, currently controversially discussed topics in Indology and South Asian studies, biographies of outstanding scholars, supporting materials such as linguistic or historical atlases or indexes of important works.

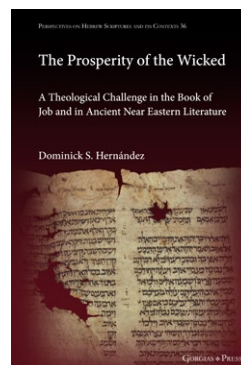

This book, *The Origin of Language: Tracing the Evolution of the Mother Tongue*, originally published in 1994 by John Wiley & Sons, was written in a more popular style, accessible to an educated general audience, than the more scholarly and academic tome of a similar title, *On the Origin of Languages: Studies in Linguistic Taxonomy*, published the same year. In *The Origin of Language* Ruhlen laid out the principles of linguistic genetic classification, i.e., classifying languages into families according to common origins rather than typological features. Ruhlen showed how simple this can be, especially for languages that have diverged for a few millennia, by juxtaposing short lists of basic (non-cultural) words like *eye*, *fire*, and *tongue*. He also showed that the same methods can be used to postulate older and deeper families, often called “macro-families” or “macrophyla,” by comparing reconstructed forms from lower-level families. Such deeper families (e.g., Nostratic, Dene-Caucasian, Nilo-Saharan, Austric) are generally more controversial than lower-level families, but Ruhlen did not shy from discussing them if he thought the evidence supported them. Ruhlen was also interested in other fields of anthropology, such as archaeology and human genetics, and brought these fields into play.

As a result, this research not only addresses block mixture as a text-critical phenomenon, it also illuminates the character of one of the New Testament's most unique manuscripts.

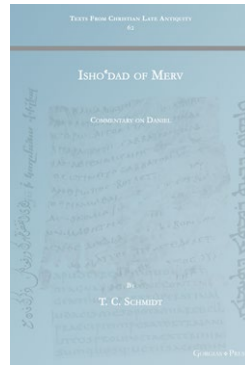

This book is based on extended fieldwork with Syriac Orthodox Christians in Bethlehem, and explores what it means to be a Palestinian Syriac Christian in the midst of radical change. It comprises a fine-grained ethnography of the ways individuals practise and represent their relationships to one another, to cherished pasts and anticipated futures. It is unusual in its careful attention to the role of Syriac Orthodox ritual and in its attention to different kinds of narratives, some of which circulate and others which emerge in the process of navigating uncertainty. It also seeks a way of doing anthropology that draws on the theoretical tradition of those whose lives anthropologists seek to represent, in this case the rich theological resources of Syriac Orthodoxy.

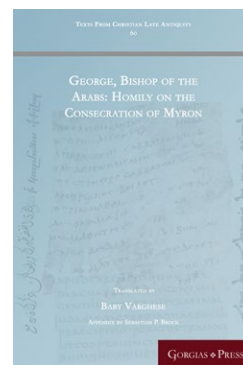

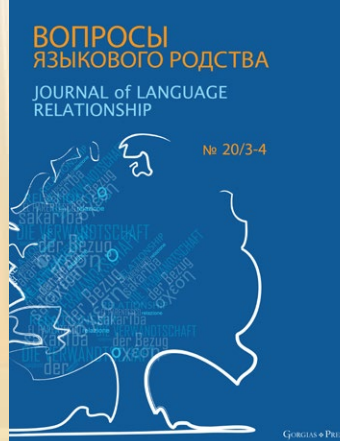

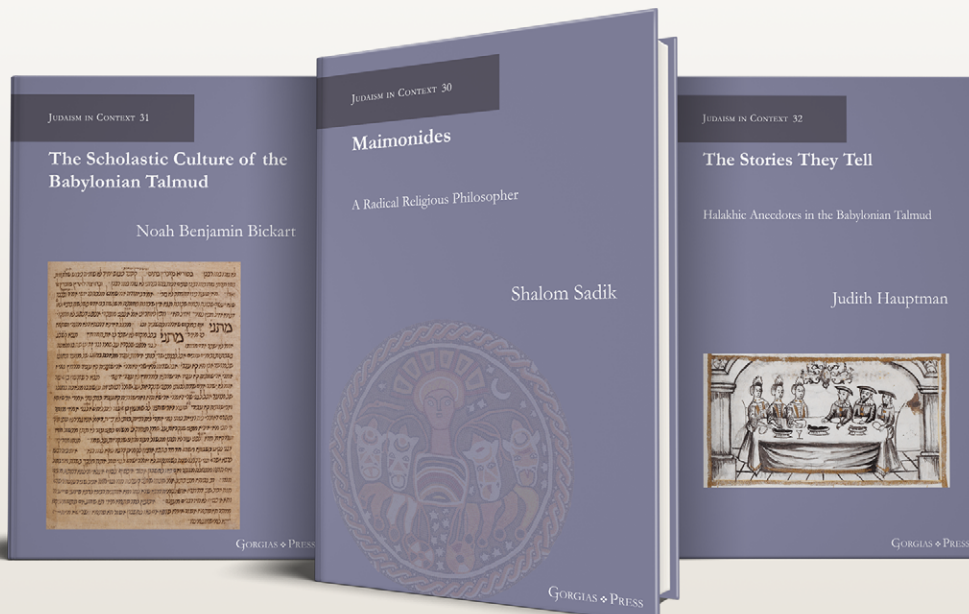

In this engaging book of commentary on the Talmud, the author upends the long-held theory of the immutability of halakhah, Jewish law. In her detailed analysis of over 80 short halakhic anecdotes in the Babylonian Talmud, the author shows that the Talmud itself promotes halakhic change. She leads the reader through one *sugya* (discussion unit) after another, accumulating evidence for her rather radical thesis. Along the way, she teases out details of what life was like 1500 years ago for women in their relationships with men and for students in their relationships with mentors. An eye-opening read by one of today's leading Talmud scholars.
