The language of the Peshitta, Syriac, is a dialect of Aramaic similar to the dialects used by Jesus and the Jewish exilic communities. While the New Testament of the Peshitta can help uncover the original ideas behind the Greek text, the Old Testament of the Peshitta is full of variants that are not preserved in either Hebrew or Greek versions of the Bible but are connected to the ancient Jewish exegetical tradition.

#### Illuminating Variant Readings

#### Luke 6:35, Revised Standard Version:

But love your enemies, and do good, and lend, *expecting* nothing in return.

#### Luke 6:35, Syriac Peshitta:

But love your enemies, do good to them, lend to them, and do not cut off any person's hope.

Most witnesses have, "love your enemies, do good to them, and lend expecting nothing in return" ( $\mu\eta\delta\dot{\epsilon}\nu\,\dot{\alpha}\pi\epsilon\lambda\pi\dot{\kappa}\lambda\sigma\tau\epsilon\zeta$ ). However, a very few (e.g. W  $\Xi$  sys) have a text that supplies a personal object for the verb ( $\mu\eta\delta\dot{\epsilon}\nu\alpha$ ), thereby requiring a different meaning for the verb, "to disappoint," or more literally, "to cut off one's hope." The Peshitta and the Sinaitic manuscript of the Old Syriac clearly share this distinctive text.

#### Daniel 11:16, Revised Standard Version:

But he who comes against him shall take the actions he pleases, and no one shall withstand him. He shall take a position in *the beautiful land*, and all of it shall be in his power.

#### Daniel 11:16, Syriac Peshitta:

The one who comes against him will do whatever he pleases, and none will stand before him. He will arise in *the land of Israel*, and it will be delivered into his hands.

Where is "the beautiful land?" The apocalyptic prophecy of Daniel 11 is ambiguous in the original Hebrew, but the Syriac version of the text provides a clear answer.



The doctrine of providence as it appears in the works of the North African Latin apologist, L. Caecilius Firmianus Lactantius. In the early fourth century the Roman Empire was struggling to come to terms with its own religious self-identity. While the persecutions under Diocletian were still raging, the rhetorician Lactantius authored several apologetic works in order to advocate for Christianity's inclusion into the traditional Roman culture. Lactantius' apologetic goal is twofold: 'to defend and build up'. The near unanimity among philosophers as to the existence of providence allowed Lactantius to engage his non-Christian audience through a concept of shared philosophical inheritance.





One of the distinctive characteristics of the writings of Ambrose of Milan is his frequent and lengthy borrowings from the works of Philo of Alexandria. He treated the 1st-century Jewish philosopher as an authoritative predecessor and made use of his works to a far greater extent than any other Church Father did. This study seeks to fill a lacuna in the current scholarship by investigating



Ambrose's use of Philo in his collection of letters, focusing on a set of three letters concerning the topic of the Genesis creation account (*Ep.* 29, 31, & 34 [PL#43, 44, & 45]). In all three cases, Ambrose fielded questions on the Six Days of Creation (*Hexaemeron*) by drawing upon Philo's treatise *De opificio mundi*. Each of these letters is undeniably Philonic and yet uniquely Ambrosian. This study seeks to clarify why Ambrose found Philo to be particularly valu-

able in spite of his Jewishness and also to investigate how Ambrose interpreted, adapted, and ultimately re-created his source.

To aid in the process of decoding these literary features, Jones examines Ugaritic, Akkadian, Egyptian, and Sumerian texts, identifying similar gestures and anatomical idioms and how they are variously interpreted in their respective contexts. Though the particular religious and cultural systems of these neighboring entities are distinct, their ideology of social values—values imbedded in the fabric of daily life and indicative of the universally shared experience of all communities—comes to the fore through the medium of gesture.

The Infancy Gospel of Thomas, like many apocryphal gospels, has been much transformed over the course of its transmission. Though composed in Greek in the second century, the gospel is extant in

a number of other languages and a myriad of forms. The most well-known form is a 19-chapter version in Greek based on late manuscripts (none earlier than the fourteenth century); but it is now widely-believed among scholars of the text that a shorter 16-chapter version preserved in Syriac, Latin, Ethiopic, and Georgian manuscripts is closer to the gospel's original form. Of these manuscripts, those in Syriac are by far the most important: two of them are very early (fifth/sixth centuries) and thus their text has undergone fewer changes than the texts of the other witnesses. Any study of the Infancy Gospel of Thomas needs to take account of the Syriac tradition, now possible with this new critical edition. Wider studies of Syriac literature and history also benefit from this edition as the gospel was very popular in the Syr-ian milieu where it generated a number of further translations (an Arabic Infancy Gospel of Thomas, and sections incorporated into the Arabic Infancy Gospel and the Armenian Infancy Gospel) and became incorporated into two popular Life of Mary collections. The present volume includes a history of scholarship on the Syriac Infancy Gospel of Thomas, a description of the extant manu-scripts (now numbering over twenty and divided into three recensions), and editions and translations of each recension of the text.

uscripts that testify to the extended and intensive Mu'tazilite past in the various centers of Zaydi scholarship in the Caspian region, in Hurāsān, and in Rayy. Among the few Mu<sup>c</sup>tazilite Zaydi works preserved in the libraries of Iran is a miscellany held by the library of the Faculty of Medicine at the University of Shiraz ('Allāma Ṭabātabā'ī Library). The maǧmū'a, a facsimile of which is included in the present publication, was written between 673/1274-75 and 676/1277 and contains doctrinal works by Imāmi and Zaydi theologians from both Iran and from Yemen.
